## Investment Objective 投資目標

This Fund aims to achieve long-term capital appreciation through investing at least 70% of its net assets in a diversified portfolio of securities of companies with substantial business interests in the Greater China Region (which includes Mainland China, Hong Kong and Taiwan) which are listed or traded on the stock exchanges of Shanghai, Shenzhen, Hong Kong, Taipei or other overseas exchanges and which are currently under-valued but which may have long-term potential. This Fund's investments, as described above, will generally be in equity and equity related securities of its target companies, including common stocks, preferred stocks, China A-Shares Access Products and depository receipts issued by such companies, in all cases, within the limits of the investment and borrowing powers and restrictions contained in the Prospectus. the limits of the investment and borrowing powers and restrictions contained in the Prospectus. Investments of this Fund may also include A-Shares and/or B-Shares listed on the Shanghai Securities Exchange ("SZSE") in Mainland China.
