Terms and Conditions

1. The Manulife InvestChoice 0% Fund Subscription Fee Offer (the “Offer”) will take place from 26 July to 31 December 2023, both dates inclusive (the “Promotional Period”).
2. Only holders of Manulife InvestChoice Accounts (“Eligible Clients”) are eligible to participate in the Offer.
3. Eligible Clients who meet one of the following requirements will enjoy the Offer:
 - (i) “Existing Client” – hold a single-name or joint-name Manulife InvestChoice Account before 26 July 2023 and during the Promotional Period enter the promo code [FUND2023] to the lumpsum subscription instruction online for the first time and all subsequent lumpsum subscriptions conducted for the same Manulife InvestChoice Account up till the Promotional Period end will be included in the subscription fee waiver calculation. The sooner you enter the promo code, the longer time for you to get more fee waivers.
 - (ii) “New Client” – open a new single-name or joint-name Manulife InvestChoice Account online for the first time during the Promotional Period all lumpsum subscriptions conducted for the new Manulife InvestChoice Account up till the Promotional Period end will be included in the subscription fee waiver calculation.
4. Each New Client who holds existing Manulife MPF account(s) and/or in-force insurance policy(ies) and meet the above requirements will receive an additional HK\$300 cash reward.

Each New Client who holds Manulife Advanced Fund SPC (“MAF”) shareholder account, Manulife Global Fund (“MGF”) shareholder account, Manulife Hong Kong Series (“MHK”) unitholder accounts and meets the above requirements together with a complete transfer of ALL the fund units held in such MAF/MGF/MHK accounts to the new Manulife InvestChoice Account; will receive an additional HK\$300 cash reward.
