## Climate Metrics Disclosure for Funds Managed and Operated by Manulife Investment Management (Hong Kong) Limited


## Introduction

At Manulife Investment Management Hong Kong Limited ("**Manulife IM (HK)**"), we believe that climate change is a systemic risk that may have an imminent and potentially irreversible impact on the global economy, capital markets, and society at large. These impacts will manifest as both risks and opportunities for almost all companies in all industries and therefore must be properly assessed by investors in order to safeguard clients' assets.

As part of the framework to govern its management of climate-related risks, Manulife IM (HK) monitors sustainability risks and factors relevant and material to an investment including <u>climate-related risks</u>. Portfolio Carbon Footprint is considered to be a meaningful metric in assessing climate-related risks of the funds managed and operated by Manulife IM (HK).

## **Portfolio Carbon Footprint**

Portfolio carbon footprint is a representation of carbon emissions normalised by the portfolio's market value and expressed in tons of carbon dioxide equivalent emissions (CO2e) per million dollars invested. Below is the formula for the calculation of portfolio carbon footprint<sup>1</sup>:



The portfolio carbon footprint of the funds managed and operated by Manulife IM (HK) calculated using the formula above are shown in the tables below.
