JPMorgan Investment Funds (SICAV Range)

We are writing to inform you of certain changes to the sub-funds (“**Sub-Funds**”) of the Fund.

1. Removal of expected and maximum securities lending levels for JPMorgan Investment Funds - Global High Yield Bond Fund

Previously, the Hong Kong Offering Documents disclose that JPMorgan Investment Funds - Global High Yield Bond Fund may engage in securities lending transaction up to a maximum level of 20% with the expected level to be 0% to 20%:

The Hong Kong Offering Documents have been amended to remove the expected and maximum levels of securities lending transactions for the above Sub-Fund since the Sub-Fund is no longer part of the securities lending program.

There is no material change to the risk profile of the above Sub-Fund.

2. Other general updates

The Hong Kong Offering Documents have been amended to reflect certain general updates including:

- addition of “operational risk” disclosures;
- update of the list of conducting officers of the Management Company; and
- other enhancement of disclosures.

The Hong Kong Offering Documents of the Fund and the Product Key Facts Statements of the Sub-Funds are available free of charge upon request during normal working hours at the registered office of JPMorgan Funds (Asia) Limited¹, and on our website am.jpmorgan.com/hk².

此函旨在告知閣下有關基金的子基金（「**子基金**」）的若干變更。

1. 刪除摩根投資基金－環球高收益債券基金的證券貸出的預期及最高水平

此前，香港銷售文件披露，摩根投資基金－環球高收益債券基金可從事證券貸出交易，最多達最高水平20%，而預期水平為0%至20%。

由於子基金不再是證券貸出計劃的一部分，香港銷售文件已作出修訂，以刪除上述子基金的證券貸出交易的預期及最高水平。

上述子基金的風險取向並無重大變化。

2. 其他一般更新

香港銷售文件已作出修訂，以反映若干一般更新，包括：

- 新增「操作風險」披露；
- 更新管理公司的經營主管名單；及
- 其他加強披露。
